

Pricelist of services and fees - valid from 1st July 2023

1 The accommodated person's own appliances

It is possible to bring, place and use one's own electrical devices and appliances at the Halls of Residence only if they comply with safety standards. The owner of the device is responsible for a safe operation of the device. Placing and using one's own electrical appliances with a fee (paragraph B) is possible only on the basis of the previously approved "Request on placing an electrical appliance".

A. appliances used WITHOUT A FEE

curler, hairdryer, charger, electric razor, electric alarm clock, lamp
audio - video – IT equipment
electrical appliance with a power max. 2000W (including electric kettle)
fridge or freezer in the energy class A

B. appliances FORBIDDEN

fridge without a proven energy class
convector heater, space heater, radiant panels or other devices used for heating or air-conditioning of the room
deep fat fryer
electrical appliances with a power higher than 2000W
fridge or freezer in the energy class B and higher (mark till 1st March 2021) or E and higher (from 1st March 2021)

2 Appliances to be rented
